STATEMENT: Mayor Kalvaitis read the notice of this meeting pursuant to the "Open Public Meetings Act."

Mayor Kalvaitis introduced Dr. Nancy Ward, Superintendent and Joanne Augustine, Business Administrator, from the Runnemede Public Schools who presented an overview of their budget. Council President Beatrice had some questions regarding special education funding in the district. Resident, Gene Smith, asked about the impact of the school budget in conjunction with the reassessment and about salary increases for the faculty and administration. Resident Eleanor Kelly asked how many special needs children are in the school system.

APPROVAL OF MINUTES: A motion was made by Kisielewski, seconded by White that the minutes of the 3/6/12 meeting be approved as submitted by the clerk. The motion carried.

REPORT OF CONSTRUCTION CODE OFFICIAL: A report was read stating that the sum of \$8,344.00 was collected in various building permits and license fees during the month of March, 2012. All fees were turned over to the Borough Treasurer.

REPORT OF BOROUGH TREASURER: A report was read indicating deposits on account as of 3/30/12 totaled \$3,216,184.79.

REPORT OF BOROUGH CLERK: A report was read reporting that the sum of \$183.00 was collected in various permits and licenses together with \$7,054.80 in dog & cat license fees during the month of March, 2012. All fees were turned over to the Borough Treasurer.

All funds were turned over to the Borough Treasurer.

REPORT OF REGISTRAR OF VITAL STATISTICS: A report was read reporting that the sum of \$3,450.00 was collected for vital statistic documents during the month of March, 2012. All fees were turned over to the Borough Treasurer.

REPORT OF FIRE OFFICIAL: A report was read reporting inspections and activities during the month of March, 2012. Fees in the amount of \$6,421.49 were collected. Emergency Medical Service Billing for the month of March, 2012 was \$36,506.09. All fees collected were turned over to the Borough Treasurer.

ORDINANCE #12-01

AN ORDINANCE AMENDING CERTAIN PROVISIONS OF CHAPTER 316 OF THE CODE OF THE BOROUGH OF RUNNEMEDE COUNTY OF CAMDEN, STATE OF NEW JERSEY

WHEREAS, Mayor and Council of the Borough of Runnemede believe it is in the best interest of the residents of the Borough of Runnemede to amend certain provisions of Chapter 316 of the Municipal Code entitled Garbage and Rubbish Collection; and

WHEREAS, the governing body wishes to amend the Municipal Code to include provisions to regulate the storage of garbage and rubbish upon any property within the Borough of Runnemede; and

NOW, THEREFORE, BE IT ORDAINED by Mayor and Council of the Borough of Runnemede, County of Camden, and State of New Jersey, that Chapter 316-2 of the Municipal code of the Borough of Runnemede shall be amended to read as follows:

§316-2. Storage, disposal and use restrictions; abatement of nuisances

- A. No person shall place any garbage or rubbish in any street, alley or other public place, or upon any private property, whether owned or occupied by said person or not, within the limits of the Borough, unless the same is placed in a proper receptacle for collection or under an expressed approval granted by the Council.
- B. No person shall throw, deposit or place any refuse in such a manner that the elements may carry same onto any other public or private property or into any watercourse or body of water.
- <u>C.</u> No person shall use garbage or rubbish for purposes of fill or for the construction of any land, driveway or right-of-way, or permit same to remain on any private property.
- <u>D.</u> Any violation of this section is hereby declared to be a nuisance and subject to abatement as such in the manner provided by the Borough.
- <u>E.</u> Nonresidential properties shall be limited to two receptacles per week and all garbage shall be properly placed in receptacles as defined in $\S 316-4$.
- <u>F.</u> There shall be no limitation upon the amount of recyclables permitted to be placed for collection by any person for either a residential or nonresidential property.
- G. All garbage and rubbish upon any property within the limits of the Borough not placed for collection pursuant to §316-5 shall be stored in the rear yard of the property in a neat and orderly fashion and in receptacles as defined in §316-4.
- H. All garbage and rubbish upon any property within the limits of the Borough not placed for collection pursuant to §316-5 shall be stored so that it is not visible from the street
- BE IT FURTHER ORDAINED, all ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to such inconsistencies; and

BE IT FURTHER ORDAINED, all ordinances or parts of ordinances not inconsistent with this ordinance shall remain in full force and effect; and

BE IT FURTHER ORDAINED, that this Ordinance will take effect after adoption and publication according to law.

Councilman Nick Kappatos stated that he had received the police contract at 7 PM the evening before. Nick wanted more time to review the contract since it had been previously ratified by Mayor & Council last June and he thought any changes that were made since that time should be verified. Councilwoman Passio stated that she had just received the contract and wanted more time to review it. Richard Wright, Administrator, explained that Councilwoman Passio would not be signing the contract since she was not on council when it was ratified. Council President Beatrice stated that the public safety committee, together with the administrator, had met that day and gone over the contract line by line and that all was in order. Councilman Kisielewski again made the motion to adopt Resolution #12-62 amending the police contract previously ratified in June, 2011. Mayor Kalvaitis declared the resolution adopted.

WHEREAS, the Mandatory Source Separation and Recycling Act, P.L. 1987, C. 102 has established a recycling fund from which tonnage grants may be made to municipalities in order to encourage local source separation and recycling programs; and

WHEREAS, it is the intent and spirit of the Mandatory Source Separation and Recycling Act to use the tonnage grants to develop new municipal recycling programs and to continue and expand existing programs; and

WHEREAS, the New Jersey Department of Environmental Protection is promulgating recycling regulations to implement the Mandatory source separation and Recycling Act; and

WHEREAS, the recycling regulations impose on municipalities certain requirements as a condition for applying for tonnage grants, including, but not limited to make and keeping accurate, verifiable records of materials collected and claimed by the municipality; and

WHEREAS, a resolution authorizing this municipality to apply for such tonnage grants will memorialize the commitment of this municipality to recycling and indicate the assent of Mayor and Council, Borough of Runnemede, to the efforts undertaken by the municipality and the requirements contained in the Recycling Act and recycling regulations; and

WHEREAS, such a resolution should designate the individual authorized to ensure that the application is properly completed and timely filed.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Runnemede hereby endorses the submission of a 2011 Municipal Recycling Tonnage Grant Application to the New Jersey Department of Environmental Protection, Office of Recycling and designates John Gunn, Jr., Recycling Coordinator, 24 N. Black Horse Pike, Runnemede, N.J. to ensure that the said application is properly filed.

RESOLUTION #12-55

RESOLUTION CERTIFYING THE SUBMISSION OF EXPENDITURE FOR TAXES PAID ON SOLID WASTE BOROUGH OF RUNNEMEDE, COUNTY OF CAMDEN, STATE OF NEW JERSEY

WHEREAS, the Recycling Enhancement Act, P.L. 2007, chapter 311, has established a recycling fund from which tonnage grants may be made to municipalities in order to encourage local source separation and recycling programs; and

WHEREAS, there is levied upon the owner or operator or every solid waste facility (with certain exceptions) a recycling tax of \$3.00 per ton on all solid waste accepted for disposal or transfer at the solid waste facility; and

WHEREAS, whenever a municipality operates a municipal service for solid waste collection, or provides for regular solid waste collection service under a contract awarded pursuant to the "Local Public Contracts Law", the amount of grant monies received by the

municipality shall not be less than the annual amount of recycling tax paid by the municipality except that all grant moneys received by the municipality shall be expended only for its recycling program.

NOW, THEREFORE BE IT RESOLVED, by Mayor and Council of the Borough of Runnemede hereby certifies a submission of expenditure for taxes paid pursuant to P.L. 2007, Chapter 311, in 2011 in the amount of \$9,057.18. Documentation supporting this submission is available at 24 N. Black Horse Pike, Runnemede, NJ 08078 and shall be maintained for no less than five years from this date.

RESOLUTION #12-56

Resolution Opposing Senate Bills 1451 and 1452

WHEREAS, legislation has been introduced to reform and modernize both the Open Public Meetings Act (S-1451) and the Open Public Records Act (S-1452); and

WHEREAS, the governing body of the Borough of Runnemede agrees with and supports the statement that "the right of the public to be present at all meetings of public bodies, and to witness in full detail all phases of the deliberation, policy formulation, and decision making of public bodies, is vital to the enhancement and proper functioning of the democratic process"; and

WHEREAS, the changes, however, proposed in S-1451 will not only be a cost driver for local and State government but make government less effective; and

WHEREAS, S-1451 includes a number of proposed requirements which involve costly unfunded mandates, impractical requirements and impediments to the democratic process, including the following:

1A new definition of subcommittees that expands subcommittees to be overly inclusive so that, for example, even research projects assigned to one member of a public body could be covered; and

2A new requirement that all subcommittees meetings include notice of their meeting and the preparation of minutes, which would, among other things, necessitate additional administrative support for all meetings of subcommittees as well as increased legal advertising cost; and

3A new requirement that agendas provide a description of all agenda items, including the names of parties to and approximate dollar amounts of any contracts to be acted upon, which will delay the award of contracts and could lead to the loss of grant monies; and

4A new requirement that the governing body may discuss, but not act upon, an item brought up by a citizen at a public meeting if it was not published as an agenda item, that not only runs contrary to the time honored tradition of holding a public meeting for the very purpose of soliciting such input and acting upon it but is impractical, ineffective and unnecessarily inhibits the operations of municipal government; and

5A new requirement for advance notification of estimated start times for the public portion of the meeting and the portion of the meeting from which the public is to be excluded that is unworkable and disruptive; and

6A new requirement that recordings of meetings become a part of the minutes that renders the recordings a permanent municipal record and is not only counter to the already-established records retention schedule of Division of Archive and Records Management for such records but which will be costly to preserve the records to ensure that they are permanent; and

7A new requirement that electronic communications, such as e-mails and text messages, concerning public business among an effective majority of the members that occurred prior to a meeting become part of the minutes and renders the recordings a permanent municipal record, is unworkable and unmanageable as the technology does not always exist to make "hard copies" or digital copies of text messages and the records custodian does not always have access to them, and which is an unprecedented expansion of the meeting concept; and

8A new requirement that public bodies be permitted to exclude the public from discussion of personnel matters only with the written consent of the employee and potentially affected employees which will inhibit the public bodies' ability to take necessary actions on personnel matters and could lead to costly litigation; and

9A new requirement that comprehensive minutes that must include each member's stated reason for their actions or vote, the identity of each member of the public who spoke, and summary of what was said, be made available to the public as soon as possible but no later than 45 days after the meeting that will not only be costly but the historical value of minutes will be lost in order to meet an arbitrary deadline; and

WHEREAS, the governing body of the Borough of Runnemede agrees that government records should be readily accessible and transparent but there must be an appropriate balance between the need for openness and transparency in government and citizens' reasonable expectation of privacy; and

WHEREAS, among the costly unfunded mandates and impractical new requirements of S-1452 are the following:

- . The expansion of the definition of government record to include records that are required by law to be made, maintained or kept on file by any public agency that will lead to a records custodians to be in violation of OPRA for the non-existence of a government records created before their tenure with the public body; and
- . The creation of a definition for "advisory, consultative or deliberative" material that may be contrary to the well established definition in case law leading to costly litigation; and
- . The expanding of the definition of government record to include electronic communications, such as e-mails and text messages, concerning public business among an effective majority of the members that occurred prior to a meeting that is unworkable and unmanageable as the technology does not always exist to make "hard copies" or digital copies of text messages, the records custodian does not always have access to the electronic communications and certain cell phone carriers will not provide this information without a subpoena; and
- . The inclusion of a subjective definition for "reasonable" that may be contrary to the well established definition in case law leading to costly litigation; and

- A new requirement that any video or audio recordings or public meetings should be available in unedited form will be in direct violation of the Open Public Meetings Act requirement that requires the redacting of discussions in closed session until the matter can legally be released; and
- A new requirement on how to handle redactions and special services fees is time consuming and costly, especially considering that the Government Records Council has already addressed these procedures in their Custodians' Toolkit, which should be codified; and
- . A provision that permits the records custodian to advise a requestor that a government record is readily available on the public agency's website; however, the bill requires the records custodian to directly provide the records to the requestor if they do not have access to a computer but does not define what is meant by "access to a computer"; and
- . A new costly requirement that when there is a special service charge the requestor must be provided, at no cost, an index generally describing the responsive government records to be provided and to the greatest extent possible the index shall include the name of each record or brief description of the record or general categories of records, a detailed breakdown of how the special charges were assessed and if records are exempt or redacted, the records custodian must provide a description of those records; and
- A provision that prohibits the assessment of a special service charge for requests for budgets, bills, vouchers, contracts and public employee salaries and overtime unless the request is deemed voluminous, which is undefined and subjective; and

WHEREAS, the provisions of S-1451 and S-1452 place financial, time, manpower and other burdens on municipalities at a time when municipalities are forced to layoff municipal employees, impose furloughs and reduce departmental budgets so that municipalities can meet the strict CAP requirements with decreased revenues and increasing operating expense; and

WHEREAS, the totality of the new requirements of S-1451 and S-1452 will be a significant cost driver for local and State government with no known appropriation contemplated or any alternate means to offset these costs, such a reasonable increase in fees; and

WHEREAS, while the governing body of the Borough of Runnemede strives for and agrees that open and transparent government is essential to the democratic process, the provisions of S-1451 and S-1452 will make government inefficient;

NOW, THEREFORE, BE IT RESOLVED that the governing body of the Borough of Runnemede, County of Camden, and State of New Jersey for reasons stated above, does hereby oppose S-1451 and S-1452, as currently drafted, and strongly urges the State Senate and Assembly to oppose these bills; and

BE IT FURTHER RESOLVED that a copy of this duly adopted resolution be forwarded to Senate President Stephen Sweeney, Senator Loretta Weinberg, Senator Barbara Buono, Senator Shirley Turner, Assembly Speaker Shiela Oliver, Assemblyman Gordon Johnson, Assemblyman Upendra Chivukula, the legislators of the Fifth Legislative District, Governor Chris Christie, the New Jersey State League of Municipalities and the Municipal Clerks' Association of New Jersey.

RESOLUTION #12-58

RESOLUTION CALLING FOR THE RESTORATION OF ENERGY TAXES TO MUNICIPALITIES

WHEREAS, taxes on gas and electric utilities were originally collected by the host municipalities to be used for local purposes and to compensate the public for the use of their rights of way; and

WHEREAS, when the State made itself the collection agent for these taxes, it promised to dedicate the proceeds to municipal property tax relief; since, just as municipalities collect property taxes for the benefit of school districts, counties and other entities; the State is supposed to collect Energy Taxes for the benefit of municipal governments; and

WHEREAS, for years, though, State budget makers have diverted funding from Energy Taxes to fund State programs; and instead of being spent on local programs and services and used to offset property taxes, the money has been spent as successive Legislatures and Administrations have seen fit; and

WHEREAS, while the State may need to have the right to over-ride the statutory dedication of these revenues to local governments, in order to deal with emergencies and crises that may occur; current State policy makers should not exercise that right automatically; and

WHEREAS, while that right should be the exception, it has become the rule; and

WHEREAS, by using tactics such as reducing CMPTRA, which is also comprised of revenues that should be returned to municipalities, State Budget makers have been able to continue collecting Energy Taxes, while keeping additional revenue that should have been returned to provide property tax relief; and

WHEREAS, from \$72 million in State Fiscal Year 2005, to \$505 million in State Fiscal Year 2011, the State's diversion of Energy Taxes has continued to grow; and

WHEREAS, in 2008, 2009 and 2010 (SFY 2009, 2010 and 2011), funding for municipal revenue replacement was slashed by about \$26 million in 2008 and \$32 million in 2009, followed by losses of about \$271 million in 2010; and

WHEREAS, the cumulative impact of years of underfunding has left many municipalities with serious needs and burdensome property taxes; and

WHEREAS, local elected officials are in the best position to decide the best use for these resources, which were always intended to fund local programs and services;

NOW THEREFORE BE IT RESOLVED, by the Mayor and Governing Body of the Borough of Runnemede that we join with the League of Municipalities in calling for the immediate restoration of funding diverted from Energy Taxes intended for local use; and

BE IT FURTHER RESOLVED, that we, respectfully, call on State policy makers to end the diversion of our municipal resources to cover State spending and to provide us with this important tool to relieve the worst-in-the-nation property tax burden borne, for too long, by the people of New Jersey; and

BE IT FINALLY RESOLVED, that copies of this Resolution be forwarded to the Governor of the State of New Jersey, our State Legislators and the League of Municipalities.

Dear Mayor and Borough Council:

By way of introduction, the undersigned is attorney for Land Approvals Group, LLC, with respect to a Land Use Application currently pending before the Combined Planning/Zoning Board of Adjustment that was originally filed December 8, 2011. My client's Application proposes a mixed use of single-family attached dwellings (32) and townhouses (27) for the vacant parcel identified as Lot 1 of Block 149.01 on the Borough of Runnemede Tax Maps. It is important to note that both townhouses and single-family detached dwellings are permitted principal structures under the R-3 Residence District Zoning Regulations codified within Section §395-8B of the Zoning Code.

The purpose of this correspondence is to respectfully request that the Borough Council address a deficiency and omission from the Township Code concerning Section §395-8 of the Township Code pertaining to townhouses. Specifically, although townhouses within the R-3 Zoning District are permissible structures, the Borough has not provided bulk and area standards for townhouses within the R-3 Zoning District. I have attached hereto for your review, a copy of Ordinance No. 11-02 that was adopted by the Borough Council last year on April 5, 2011. Put simply, the omission of definitive bulk standards and area regulations for the development of townhouses within the Borough creates a significant issue not only for the Borough, but also for my client and any potential developer seeking to develop townhouses within the R-3 Zoning District. The omission of appropriate bulk and area regulations could be rectified, however, by an Ordinance approved by the Borough Council adopting bulk and area regulations for the R-3 Zoning District and I have attached hereto, a copy of the draft Master Plan Report that was

prepared by the Borough Planner creating bulk and area regulations for the townhouse units contemplated for the R-3 Zoning District.

On behalf of my client, I would respectfully request that the Borough Council discuss this matter at the next regular scheduled meeting on April 3, 2012. I would be happy to appear at such meeting on behalf of my client, should the Council require any additional information or clarification with respect to curing the Ordinance deficiency referenced above.

The following was part of the draft Master Plan report in October/November 2010, but was removed by the Planning Board in November 2010. The Master Plan Reexamination was adopted by the Planning Board on December 8. The chart with bulk requirements was included in the Master Plan, but without the second two columns shown below and without the design standards below. The concern now is that in accordance with the ordinance adopted by Borough Council on April 5, 2011, townhouses are permitted at a density of 3 dwelling units per acre, but there are no specific standards to guide the development of townhouses. the information below may be of use to the Planning Board and Council in considering whether the ordinance should be amended to eliminate the townhouse use or to add a standards for townhouses.

The Planning Board recommends that a maximum density of three dwelling units per gross acre (3 du/acre) be applied for new development in the R-3 district, and that residential lots a minimum of 6,000 square feet be permitted when at least 25% of the total lot area is set aside as common open space. Assuming that 30% of a development tract would be required for roads, stormwater management and other infrastructure, the 3 unit per acre density would allow for medium density development along with the provision of common open space areas. For example a 10 acre tract could be developed with 30 homes on 6,000 square foot lots, along with 2.5 acres of open space in addition to the roads and stormwater areas.

- F. Design Standards for Cluster/Conservation Subdivisions and Townhouses.
 - 1. The purpose of providing for the Cluster/Conservation subdivision provisions is to provide a flexible subdivision design approach that considers the environmental and physical attributes of a site, the site's relationship to the surrounding area, and the most desirable and appropriate locations for home sites. The cluster provisions are intended to allow for planned development that will balance residential development with the protection of wooded and environmentally sensitive lands. The cluster provisions will allow residential developments to be constructed at a lower cost per dwelling for streets, utilities and other site improvements, while also providing recreational opportunities that are appropriate to the needs of and convenient to the residents of the Borough. Further the cluster provisions may reduce the amount of clearing, grading, and construction disturbance resulting from subdivisions and to increase the quantity and quality of open spaces, providing a desirable visual environment through creative development techniques and design arrangements.
 - 2. Conservation or open space lands should be centrally located and adjoin as many residential lots as practical in order to increase the value of the lots and provide for the enjoyment of open space by as many residents as possible. A conservation or recreation easement restriction shall be placed on open space areas to ensure that the land will be preserved in perpetuity.
 - 3. Where open space areas are behind residential lots, the open space area must have a minimum street frontage of 100 feet to ensure access to the residents of the development.
 - 4. The architecture of dwellings with frontage on two streets shall respond to both streets, with architectural details, windows and other elements that respond to the street frontage.
 - 5. In order to ensure variety among residential dwellings, houses on the same side of the street must be substantially different in appearance than other dwellings within 2 lots from it. On a cul-de-sac, any lot on the cul-de-sac is considered to be on the same side of the street. All major subdivisions for single family homes must provide a minimum of three basic house designs with exterior variations possible for each one.
 - For townhouses, if trash and recyclables will be stored in common areas, then a
 trash enclosure shall be provided with sufficient space for trash and recyclable
 materials. The enclosure must be constructed of materials to match the buildings

- and must be a minimum of 6 feet high and surrounded by landscaping. A pedestrian entrance to the enclosure must be provided so the gates are not frequently left open.
- 7. For townhouses, in addition to RSIS parking requirements for the residential units, a shared parking area for guest parking to accommodate a minimum of.5 vehicle per residential unit shall be provided.

At the March 2012 meeting of the Borough Planning/Zoning Board, the application filed by Land Approvals Group LLC was heard and discussed.

During the course of the hearing it was determined that townhouses are permitted uses in the R-3 Zoning District (Section 395-8 of the Zoning Code). However, it was noted that the Code of the Borough of Runnemede is silent as to related bulk and area standards.

The Board directed this correspondence be sent to your attention for consideration of amendments to the Zoning Ordinance to provide for bulk and area standards as applied to townhouse developments as set forth in Section 395-8 of the Zoning Code.

The Board understands that any amendment to the Zoning Ordinance must first be reviewed and discussed at a regular meeting of the Planning/Zoning Board and a recommendation provided to Mayor and Council prior to any Zoning Ordinance amendment.

The Planning/Zoning Board desires to proceed with the evaluation and amendment process and request Mayor and Council to establish a review committee to discuss standards prior to submission to the Planning/Zoning Board.

Accordingly, if a committee of Council is established, it is respectfully requested that Mayor and Council communicate with the Chairman of the

Planning/Zoning Board to designate a Board member to participate with the committee established by Council.
