APPLICATION FOR THE BUTLER GROUP FOR MAJOR SUBDIVISION PRELIMINARY FOR BLOCK 149.01 LOT1: USE VARIANCE/DENSITY ORDINANCE: At this time Solicitor Rowan excused Mayor and Councilman Kappatos from the room.

Solicitor Barone on behalf of the applicant Mr. Butler spoke to the residents and explained the use variance and density ordinance and a proposal of a plan for 114 townhomes.

Solicitor Barone also introduced a group of specialist one being a planner, an engineer and Deanna doing the traffic study when they were through with their lengthy presentation Chairperson Klehamer Opened the public hearing on this application.
