**GOOD&WELFARE:**


Charles Buckheim-223 Sunnybrook Rd. -Mr. Buckheim stated that he was looking for a large piece of ground to possible build a new school.

There appearing to be no one else to speak a motion was made by Fullerton seconded by Dickinson that the Good & Welfare portion of the meeting be closed. The motion carried.


**ADJOURNMENT:**
