Councilwoman Kelly reported that she had met with the public safety committee and had presented a survival kit to the police chief.

Councilman Ranieri reported that the 2015 audit process was almost finished. John also reported on having the post office deliver some newsletters that were not delivered in the first mailing.

Councilman Laubenstein reported on the meeting both he and the Mayor had attended with the RYAA. Craig stated that the President of the RYAA was very rude to the Mayor. A discussion ensued regarding the soccer program in Runnemede and how to better work together with the RYAA. Councilman Laubenstein also posed a question he had received from St. Teresa's regarding cross county running.

Councilman Farrell reported on the rejection of the 2nd & Central Avenue bid and the parking lot project which may begin in September.

Councilman Root reported on the temporary employee hired and the return of the turtle sign. The Mayor also had some discussion about inlet cleaning. Councilman Ranieri asked about electric car charging stations.

Administrator Wright reported on the possibility of another bond ordinance in the fall, 2015 audit, the JIF renewal process, 3 grievances, 2 lawsuits and a mediation next month.

Public Works Superintendent Harry Wozunk reported on the new gym floor, the Vactor truck and the F450 to be purchased. Harry also had questions about when it was appropriate to cut and/or trim trees. A discussion ensued which included the solicitor regarding the issue of trimming trees or removing trees.

Solicitor Wood advised Mayor & Council as to how to proceed with DeLuxe Bakery and their failure to obtain a certificate of occupancy. Len also reminded Mayor & Council about the mediation coming up in September regarding the GWU.

Borough Engineer Mark Basehore reviewed his written status report, reminded everyone that the 2nd & Central Avenue project would be bid again in the spring and that the borough would be accepting bids on Friday for the borough hall improvements.
