MARCH 22, 2016

The Caucus Meeting of Mayor and Council of the Borough of Runnemede was held on the above date in the meeting room of the Borough Hall, 24 N. Black Horse Pike, Runnemede, NJ. The meeting was called to order at 6:00 P.M. The following members were present at roll call: Council members: Passio, Root, Laubenstein, Farrell, Kelly & Ranieri. (Councilman Root arrived at6:35 PM) Absent: Mayor Kappatos; Present: Solicitor Wood; Borough Engineer: Mark Basehore.

STATEMENT: Mayor Kappatos read the notice of this meeting pursuant to the "Open Public Meetings Act."

The following issues were discussed for the upcoming meeting:

A resolution to purchase copy paper through county coop, introduction of ordinance for boarding up structures and fire damaged buildings, a resolution to adjust sewer charges, a raffle for the lawn festival in June, a resolution transferring property maintenance charge to correct block & lot and a resolution transferring tax payment to sewer account.

Councilwoman Kelly recommended that Mayor & Council award the towing contract to Bernie's Auto at the next regular meeting.

Councilman Farrell reported on the buildings taken down next to borough hall and progress.

Councilwoman Kelly reported on the future purchase of two police cars and that she would be meeting with the fire department regarding their five year plan.

Councilman Laubenstein stated that he wanted an update on the work to be done at the girls' softball field. Mr. Dave Evangelist, 587 Sherrington Lane spoke to Mayor & Council about what needed to be done at the site.

Councilman Ranieri reported on the 2016 budget time line and the reporting requirements for the affordable care act. John also mentioned the policy updates necessary to comply with the MEL.

Councilwoman Kelly also reported on what she learned at the most recent Board of Education meeting.

Borough Engineer Mark Basehore explained the time line and steps for work to begin on the new borough hall parking lot.

Solicitor Wood stated that a closed session would be needed for about ten minutes to discuss contract negotiations.

Superintendent of Public Works, Harry Wozunk, reported on work done by his department over the past month including yard waste collection, street sweeping, installing some concrete under bleachers. Harry also reported on the renovations at the public works building and the new decals on borough vehicles. Mr. Wozunk reported that he was trying to work out a deal with the company doing the work on Clements Bridge Road to repave Hill Avenue in return for allowing their truck to park on borough property during the Clements Bridge Road project for just the cost of material.

Administrator Wright reported on budget introduction, changes to out policy manual in order to comply with JIF and our agreement with school district for tech support.

Councilman Root reported on the work done to the athletic fields in order to be ready for opening day.

Councilman Ranieri asked council have their articles ready for the newsletter.

Councilwoman Passio reported Youth Mayor & Council would begin May 7th and that there would be a dinner at Triton on April 7th.

Councilman Laubenstein asked that the little league opening day parade by moved back to the Black Horse Pike instead of from Volz school. Councilwoman Passio stated that it could be considered for next year since a permit has to be requested from the DOT.

RESOLUTION APPROVING PARTICIPATION WITH THE STATE OF NEW JERSEY IN SAFE AND SECURE COMMUNITIES

PROGRAM ADMINISTERED BY THE DIVISION OF CRIMINAL JUSTICE, DEPARTMENT OF LAW AND PUBLIC SAFETY, BOROUGH OF RUNNEMEDE, COUNTY OF CAMDEN, STATE OF NEW JERSEY

WHEREAS, the Borough of Runnemede wishes to apply for funding for a project under the Safe and Secure Communities Program; and

WHEREAS, Mayor & Council of the Borough of Runnemede has reviewed the accompanying application and has approved said request, and
