Absent: Laubenstein; Present: Borough Engineer: Mark Basehore; Public Works Superintendent: Harry Wozunk, Solicitor Len Wood. Acting Borough Administrator/CFO Robert Law arrived at 6:35 PM.

Mayor Kappatos declared the ordinance adopted on first reading.

RESOLUTION APPROVING THE LOW BID FOR THE RECONSTRUCTION OF S. OAKLAND AVENUE & WASHINGTON AVENUES PHASE II, BOROUGH OF RUNNEMEDE, COUNTY OF CAMDEN STATE OF NEW JERSEY

WHEREAS, bids were received on May 25, 2017 for the reconstruction of S. Oakland Avenue & Washington Avenues, Phase II; and

WHEREAS, six bids were received; and

WHEREAS, the low bid was received from Landberg Construction LLC. in the amount of a base bid of \$158,602.92, plus alternate bid #1 in the amount of \$68,386.30 for a total bid of \$226,989.22; and

WHEREAS, the borough engineer has recommended acceptance of this bid; and

WHEREAS, the solicitor still has to review as to form and the CFO still has to certify funds for the project; and

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Borough of Runnemede, County of Camden, State of New Jersey that it hereby accepts Landberg Construction LLC. bid in the amount of the base bid plus alternate #1 in the amount of \$226,989.22 for the reconstruction of S. Oakland & Washington Avenues, Phase II pending solicitor and CFO approval; and

BE IT FURTHER RESOLVED, that the proper officials are hereby authorized to enter into an agreement with Landberg Construction LLC.
