Council President Kappatos stated that it was now time to discuss items to be included on the agenda for 5/6/14.

Mayor & Council discussed the resignation of our fire subcode official and the desire of Keith Knight to take over this position.

Borough Administrator Richard Wright & Borough Clerk Joyce Pinto explained to Mayor & Council the need for two new copiers and proposed leasing two from Xerox via state contract.

#### BOROUGH OF RUNNEMEDE

Council President Kappatos declared the resolution adopted.

Council President Kappatos informed everyone that on the May agenda would be the following: a resolution refunding two quarters for a totally disabled veteran; a resolution canceling a disabled deduction due to an error; and a resolution appointing a crossing guard.

Council President Kappatos reported that a proposal under state contract had been received regarding the purchase of a fire truck and it was hoped that this would be on the May agenda for approval.

A discussion ensued regarding adopting an ordinance placing a moratorium of five years on street openings by utility companies after a road had been reconstructed. Borough Engineer Mark Basehore stated that he would investigate such a ordinance.

Borough Engineer Mark Basehore reported on three projects he had solicited quotes for. One was for the replacement of the front door of the borough hall. Mark recommended awarding the contract to the low quoter in the amount of \$4,958.00. Another was for the side door modifications, replacement and drywall repair in the borough hall with a low bid in the amount of \$14,100.00. Mark also recommended awarding the contract to the low quoter. The third solicitation for quotes was for door closers and crash chains at Beaver Branch Park bathrooms in the amount of \$1,460.00 which Mark recommended be awarded this evening to the low bidder.

Council President Kappatos raised the issue of amending the borough's personnel policy to include medical coverage for those not covered under contracts after retirement. Nick explained that this issue has come up on numerous occasions and needs to be addressed. Solicitor Wood stated that he would review and come up with something.
