APRIL 28, 2015

The Caucus Meeting of Mayor and Council of the Borough of Runnemede was held on the above date in the meeting room of the Borough Hall, 24 N. Black Horse Pike, Runnemede, NJ. The meeting was called to order at 6:05 P.M. The following members were present at roll call: Mayor Kappatos; Council members: Passio, Kelly, Moore, Root, Farrell & Ranieri. Absent: None; Present: Solicitor Chris Long; Borough Administrator Richard Wright; Borough Engineer: Mark Basehore.

STATEMENT: Mayor Kappatos read the notice of this meeting pursuant to the "Open Public Meetings Act."

William Harris a licensed planner hired by the borough to complete and file the Round II COAH report presented a overview of the current COAH situation.

Thomas Shannon, a consultant, introduced himself to Mayor & Council. Mr. Shannon interviewed by members of governing body and the administrator in order to provide management at public works.

The following issues were discussed:

Public Hearings for an amendment to the fee ordinance, composition of police department ordinance, land use ordinance and the purchase of property ordinance.

Also discussed was the public hearing for the 2015 budget, a bond ordinance for slip-lining pipes and solid waste disposal fees.

Other items discussed were the appointments of Judge Trabosh and a new part time EMT. The letter from the DOT granting funding for Oakland Avenue as well as authorization to submit an application to NJ State Firemen's Association for one of our firefighters was discussed.

A proclamation declaring May mental health month, a resolution to maintain landscaping and irrigation system at the "point", the right of way agreement which Fibertech has asked us to sign, the pothole agreement with Gloucester township and an emergency temporary appropriations resolution for action tonight were discussed.

Administrator Richard Wright reported on using additional surplus to decrease the local property tax.

Councilman Ranieri reported on a need for picnic tables and basketball nets. John stated that WAWA wishes to make a donation to the borough.

Councilwoman Passio reminded everyone about Youth Mayor & Council and the Memorial Day Ceremony.

Councilwoman Kelly reported on the purchase of police video cameras and public safety training.

Councilman Root reported that the Runnemede school district would be running the summer recreation program this year. Mike stated that details still need to be worked out. Some changes would be implemented such as younger age ranges and not supplying snacks.

Councilwoman Moore reported progress.

Councilman Farrell reported on the new flashing light at St. Teresa's and that the parking needs to be altered. Bob also expressed his desire to do something about Bowers Avenue. Mayor Kappatos stated that he knew Bowers Avenue needed work but given the borough's budget council would have to prioritize.

Mark Basehore, Borough Engineer, reviewed his written monthly report. Mark also reported on the need to have the developers of Callie Court resolve the road issues so that the street can be dedicated. Mark suggested using the bond posted to make the corrections.

WHEREAS, the Borough of Runnemede desires to obtain consulting services to assist them with a Temporary Superintendent of Public Works and Management Consulting Services for the Borough of Runnemede; and

WHEREAS, a proposal was received from Jersey Professional Management dated April 27, 2015, and the maximum amount of the contract in question is for a total fee of \$33,500.00, and funds are available in an appropriation entitled "Budget Line Item" and have been certified by the local finance officer, said certification being attached; and
