# RESOLUTION AUTHORIZING THE EXECUTION OF A SHARED SERVICES AGREEMENT BY AND BETWEEN THE BOROUGH OF RUNNEMEDE AND BOROUGH OF BELLMAWR FOR THE PURPOSES OF PROVIDING A BACK-UP C-2 LICENSED SEWER OPERATOR

WHEREAS, the Borough of Runnemede ("Runnemede") and the Borough of Bellmawr ("Bellmawr") have determined that the use of Bellmawr's C-2 Licensed Operator on a temporary basis would be beneficial and cost effective to Runnemede; and

WHEREAS, due to emergent unforeseen circumstances, Bellmawr would provide Runnemede through this Shared Services Agreement with routine monthly observation and reporting services and other related services traditionally performed by a License Sewer Operation for the Runnemede Sewer Collection System; and

WHEREAS, Runnemede and Bellmawr intend, by virtue of a Shared Services Agreement, to set forth certain terms and conditions of the within Shared Services Agreement; and

**WHEREAS,** the Uniform Shared Services and Consolidation Act, <u>N.J.S.A.</u> 40A:65-1 et seq. encourages and promotes local units working together in an effort to save taxpayer dollars and promote government efficiencies; and

WHEREAS, Runnemede desires to authorize the execution of a Shared Services Agreement in the form similar to that which is attached hereto and made a part hereof, subject to the final review and approval of the Municipal Solicitor.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Runnemede, as follows:

- 1. The provisions of the WHEREAS clauses set forth above are incorporated herein by reference and made a part hereof.
- 2. The Mayor or Council President are hereby authorized to execute the subject Shared Services Agreement for the use of George Coleman, Superintendent of the Bellmawr Sewer Department, as a back-up Licensed Operator, for routine monthly observation and reporting services and other related services traditionally performed by a C-2 License Sewer Operator for the Runnemede Sewer Collection System in a form similar to that which is attached hereto and made a part hereof, subject to the final review and approval of the Municipal Solicitor.

### BOROUGH OF RUNNEMEDE
